Subject: IISJ invites applications from eligible parents for membership of School Managing Committee

Applications are invited from eligible parents for the membership of School Management Committee which comprises of seven members out of which at least one will be a woman candidate. The Managing Committee is expected to contribute for the betterment of the School without any remuneration or other favours.

The interested parents fulfilling below mentioned eligibility criteria for the membership may collect the prescribed form available with the Reception Counter of Boys' Section of IIS, Jeddah w.e.f. **Sunday, February 06, 2022** to **Wednesday, February 16, 2022** between 9.00 AM to 4.00 PM.

The candidates should possess required academic qualifications and have sufficient proven experience/ specialization in Academics/ Administration / IT and Finance. The eligibility criteria for the candidates are as follows:

- a. Must be a parent of student(s) of IIS Jeddah for at least one year as per school records.
- b. To be eligible for the membership application, it is required that your ward must study in one of the classes other than grade XI and XII. The application of the parents whose wards are only in class XI & XII, will not be considered.
- c. He/ she must be a citizen of India who could devote sufficient time for the welfare of the school.
- d. Must hold a regular Bachelor's degree of 5 year programme such as MBBS or a Master's Degree of regular mode duly attested by the competent authority in India/ Embassy of India, Riyadh.
- e. He/ she must be holding a responsible position in a reputed Organization/Company or he/she should be a professional working with any reputed institution.
- f. For female member, working professionals will be given preference.
- g. He/ she should not be a school employee/ spouse of the school employee/ relative of the school employee/ member of another school committee/ former employee of the school.
- h. Must have a No Objection letter from his/ her employer/ sponsor in original, duly attested by Chamber of Commerce and Industry in which the sponsor should clearly mention that he/ she is agree for the active participation of the candidate in Managing Committee meetings and that the candidate will be in a position to attend the meetings even at a short notice.
- i. Must produce a salary certificate issued by his/ her employer and attested by Chamber of Commerce in the region stating that the monthly salary is not less than SAR 8,000/-.
- j. He/ she should submit a brief note not exceeding 100 words explaining his/ her plans to ensure better education to the children of Indian community and all round progress of the school during his/her tenure.
- k. His/ her place of work and residence should be within the city where the school is situated.
- I. The profession of the applicant mentioned in his/her employment letter should be same as mentioned in his Igama.
