## 1. GENERAL INSTRUCTIONS

### 1.1 TIMELINE

The supply and installation must be completed within 15 days, after placement of purchase order.

### 1.2 PERFORMANCE GUARANTEE

The successful bidder is required to submit a 10% of contractual amount before the commencement order is given and within 2 days of signing the final agreement. The guarantee amount in full or part may be forfeited in the following cases:

- I. When the terms and conditions of the contract are breached.
- II. When the service provider fails to comply with minimum service levels agreed upon.

Failure of the service provider to comply with statutory requirements shall constitute sufficient grounds for annulment of the award and forfeiture of service guarantee.

### 1.3 PERIOD OF VALIDITY OF BIDS

Bids shall remain valid and open for acceptance for a period of 30 days from the last date of submission of Bids.





## SECTION- I: INVITATION FOR E - BIDS (IFB)

1. The International Indian School Jeddah invites online bids from eligible bidders for Aluminium cladding works for external boundary at KG building of International Indian School - Jeddah.

**A. DETAIL SCOPE OF WORK: Technical Bid: Aluminium cladding works for external boundary at KG building with the following specification:**

### **External cladding works**

**Area of external cladding 382 Sqm.**

- Supplying and fixing of 4 mm ACP cladding with steel tubes of 40mm x40 mm 1.2 mm or 40 mm X 20mmx1.2mm with silicone Wacker.
- The ACP sheet shall be 2 hrs fire rated.
- The ACP sheet shall be through Techno Bond or a Saudi Panel SASO approved.
- The Designed will be provided by the Client.

**It is advised to visit the site to get a full understanding of the work, between 10:30 AM to 3:00 PM before 6<sup>th</sup> August 2025.**

### **2. Two bid System:**

The two-bid system will be followed for this tender. In this system, bidder must submit his offer in two separate formats as attached to this tender notice.

**Format No. 1: "Technical Bid":** Technical Bid should be prepared as per the instructions given in the Tender Documents along with all required information, documents in support of the minimum eligibility criteria. Documents comprising the Bid:

- Technical Bid Submission Form duly signed and printed on Company's letterhead (Section - I and Annexure 1)
- Contact Details Form, duly filled and signed & stamped (Annexure - 3)
- Company Profile: Shall mention Manpower and equipment details.
- The bidder must submit plan/arrangement for maintenance work and Guarantee for one year after completing the work at the site for Aluminium Cladding works for external wall at KG building.
- Other related documents e.g. Trade License, Company Registration, VAT registration certificate and other certificates issued by the respective authority should be attached with the bid documents.
- As proof of having experience, documents for completed work / ongoing work shall be attached with bid document.



**Format 2: "Financial Bid" shall contain:**

The Price Schedule/Financial Bid (Annexure-2) must be duly completed in all respects, bearing the official seal and signature of the authorized signatory, and attested by the Chamber of Commerce. Both the Technical Bid and Financial Bid should be submitted separately in a single email to [tenders@iisjed.org](mailto:tenders@iisjed.org), with the subject lines clearly marked as **"Technical Bid"** and **"Financial Bid"**, respectively.

**Note:** Please do not mention "Financial Bid" (prices quoted) in the technical bid. If the price quoted is submitted with technical bid, the tender will be rejected.

3. **Opening of Technical Bids:**

- a. All the technical bids received by the International Indian School Jeddah will be opened on 07 August 2025 at 4:00 PM at International Indian School Jeddah.
- b. After being opened, the Technical Bids will be evaluated, by the Competent Authority of the International Indian School Jeddah based on the available documents submitted by the bidder.
