Subject: Submission of Phase-2 LOC for Class X (2025-26) Second Board Examination 2026.

Dear Parents/Students,

This is in continuation of the circular dated 23-03-2026, the Second Board Examinations are scheduled to be held in May 2026 for Improvement and compartment category.

This facility is available only to students who have appeared in the First Board Examination 2026 and are otherwise eligible (passed/compartment/other categories as specified by CBSE) to apply for improvement/compartment.

Important Instructions to candidates:

- Candidates who have been placed in the compartment category are required to submit their examination form.
- Candidates who had submitted their names earlier but do not wish to appear in the Second Examination may withdraw their names.
- Candidates who wish to appear in the Second Board Examination, but whose names were not submitted during the First Phase of LOC, may now submit their names and pay the examination fee.
- Attach the required examination fee receipt as per following fees details:
 - SR 150/- + 15% VAT for 1 Subject
 - SR 250/- + 15% VAT for 2 Subjects
 - SR 350/- + 15% VAT for 3 Subjects

Submission Schedule:

- Students must submit the duly filled LOC form (attached as Annexure-A) along with the examination fee to COE office on or before 16th April 2026.

The school will not be responsible for any delay, incomplete information, or ineligible candidature arising from incorrect or late submission.
