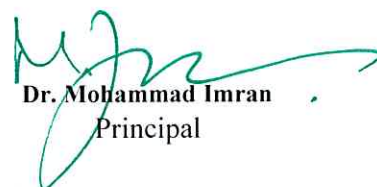

Or Bachelor's Degree with at least 50% marks in the concerned subjects/combination of subjects and in aggregate. Bachelor Degree in Science with any of the following subjects: Physics, Chemistry, Biology, Zoology, Botany, Computer Science, AI 2. Practical or Industry Experience in the concerned field 3. Ability to conduct activity-based and experiential learning. 4. Teachers Training qualification such as B. Ed or other training certificates.

Interested candidates are requested to submit the following documents:

- An updated CV;
- Copies of qualification and experience certificates, including mark sheets from 10th grade through Graduation;
- A valid Iqama ID; and
