TERMS & CONDITIONS

1. Work shall be carried out as per the instructions of the school authorities.

4. All Repairs and patch works shall be neatly carried out to match the original finish at contractor's own cost and to the entire satisfaction of the school authorities.
5. All the debris due to maintenance works shall be cleared and site shall be kept clean by the contractor at all the times.
6. The workers engaged for the work shall be qualified, well experienced to carry out the works.
7. In case of any accident during the operation/Maintenance of the equipment leading to injuries/damages to human beings/Equipment's and or loss of life, contractor shall be fully responsible for settling all the claims and indemnity. The School will not take any responsibility against any claims arising out of such accidents.
8. The contractor should possess the valid license for civil and maintenance work undertaking the said job works. Copy of valid CR, VAT registration and company profile should be attached with the quotation.
9. Rates must include all transportation, VAT and other taxes as applicable.

Scope of Work

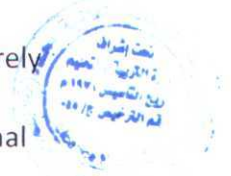
Supply, Installation, and Commissioning of Artificial Grass

The Contractor shall be responsible for the complete supply, installation, testing, and commissioning of artificial grass for the designated playground with the following dimensions:

- **Length:** 24.08 m
- **Width:** 28.72 m
- **Total Area:** 691.57 m²

The scope of work shall include following:

- 1. Site Preparation**
 - Remove all debris, unsuitable materials.
 - Carry out leveling, grading, and compaction of the existing ground to provide a stable, uniform, and well-prepared base for the artificial grass installation.
- 2. Supply of Artificial Grass**
 - Supply high-quality artificial grass that is UV-resistant, fire-resistant, non-toxic, child-safe, and specifically designed for outdoor playground.
 - The artificial grass shall be durable, weather-resistant, and suitable for heavy pedestrian use.
- 3. Base Materials and Accessories**
 - Supply and install all required base materials, geotextile (if required), joint tapes, adhesives, fixing pins, edging materials, infill materials (if applicable), and all other accessories necessary to complete the installation.
- 4. Installation**
 - Ensure accurate alignment, secure and concealed joints, proper fixing, and adequate drainage to prevent water accumulation.
- 5. Finishing Works**
 - Trim and neatly finish the artificial grass around playground edges, boundaries, existing structures, equipment, and fixtures to achieve a clean, safe, and professional appearance.
- 6. Cleaning and Waste Removal**
 - Clean the entire work area upon completion.
 - Remove and legally dispose of all surplus materials, debris, packaging, and waste generated during the works.
- 7. Inspection, Testing, and Handover**
 - Conduct a final inspection to verify that the installation complies with the project specifications and quality standards.
 - Perform all necessary testing to ensure the artificial grass system is securely installed, safe for use, and functioning as intended.
 - Hand over the completed playground in a clean, safe, and fully operational condition, together with the manufacturer's warranties, maintenance instructions, and all relevant documentation.
