Subject: CBSE Class XII – Special Examinations 2026 for Students in West Asia

Dear Parents and Students,

This is to inform you that the CBSE has issued Notification No. CBSE/COORD/EXAMS/WAC/2026/16061 dated 15.09.2026 regarding the conduct of Special Examinations for Class XII students in West Asian countries whose results were declared under the Assessment Scheme after certain Board examinations could not be conducted.

The Special Examination will be conducted in the 40 subjects (List Attached) that were previously cancelled in the affected West Asian countries, including Saudi Arabia. **Eligible candidates may appear in subject(s) of their choice from the subjects listed by CBSE.**

1. Important Schedule for Submission of LOC (No extension will be granted.)

Opening of LOC submission	22 September 2026 (Tuesday)
Last date for LOC submission	26 September 2026 (Saturday)

The link for submission of the LOC will be made available on the CBSE website on 22 September 2026.

Candidates must submit the LOC personally within the prescribed schedule.

2. Important General Instructions

- No examination fee will be charged for the Special Examination.
- The examination will be conducted only in the affected West Asian countries, including Saudi Arabia. Examination will not be conducted in any other country. **The examination centres will remain unchanged.**
- The date sheet of the Special Examination will be communicated after completion of the LOC submission.
- No post-result declaration facility will be available.
- Candidates who remained absent in the CBSE Main Examination 2026 for any reason are not eligible to appear in the Special Examination.
- No subject change will be permitted after submission of the LOC. Examinations will not be conducted in subjects which were already held by CBSE during the Main Exam 2026.

3. VERY IMPORTANT – Result of Special Examination

Parents and students are advised to carefully note that the result of the Special Examination will be FINAL and will replace the earlier performance. **It will NOT be treated as a "better-of-two" result.**

Therefore, students should carefully assess their existing result and their academic requirements before deciding to appear in any subject. Take note that the result obtained in the Special Examination will be final and will replace the earlier result/performance.

Students and parents are advised to read the CBSE Notification No. CBSE/COORD/EXAMS/WAC/2026/16061 dated 15.09.2026 carefully before submitting the LOC (Attached herewith).

This circular is issued for the information and necessary action of all concerned Class XII students and parents.

Subject:- Submission of List of Candidates (LOC) for Class XII-2026 Special Examinations for students in West Asia only-reg.

Madam/Sir,

The Board Examinations 2026 for Class XII in 40 subjects (20 academic and 20 skill) could not be conducted in the West Asian Countries due to the prevailing situation.

The CBSE, being committed to the welfare and academic future of its students, had notified an Assessment Scheme on 27 March 2026 for result preparation of such candidates. Accordingly, results for all regular candidates from West Asian countries were declared on 13 May 2026, along with other Class XII candidates in India and abroad. The results of Private candidates from these countries were also subsequently declared under the same scheme.

The Assessment Scheme dated 27 March 2026 provided that students dissatisfied with their results may be given an opportunity by conducting examinations in subjects, that could not be held.

In compliance with the decision of the Hon'ble Supreme Court in CWP-815 of 2026, CBSE has now decided to conduct examinations for all such Class XII candidates in West Asian countries, whose results were declared under the Assessment Scheme, in the 40 subjects that were previously cancelled.

1. Eligibility

A. Regular Candidates

- (a) Students of affiliated schools in West Asian countries whose LOC was submitted for the Main Examinations 2026 and whose results were declared under the Assessment Scheme.
- (b) Candidates may appear in subjects of their choice.
- (c) The result of this examination shall be final and will replace the earlier performance.

- (d) Candidates must submit their LOC personally within the prescribed schedule.

B. Private Candidates

- (a) Private category students of West Asian countries, who had submitted their examination forms for the Main Examinations 2026 and whose results were declared under the Assessment Scheme.
- (b) Candidates may appear in subjects of their choice.
- (c) The result of this examination shall be final and will replace the earlier performance.
- (d) Candidates must submit their examination forms personally within the prescribed schedule.

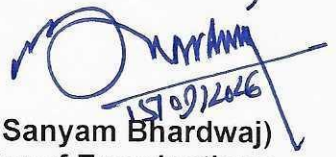

3. General Conditions

- (a) Examination date and the date sheet of the examinations will be informed once the LOC/Forms are filled.
- (b) LOC / Examination forms must be submitted directly by eligible candidates.
- (c) No examination fee shall be charged.
- (d) Examinations will be conducted only in affected West Asian countries (Bahrain, Iran, Kuwait, Oman, Qatar, Saudi Arabia and UAE). Examinations will not be conducted in any other country.
- (e) Examination centres will remain unchanged.
- (f) No post-result declaration facilities shall be made available.
- (g) Schools in West Asian countries must disseminate this notification to all concerned Class XII candidates.
- (h) Candidates who remained absent during the Main Examinations, 2026, for any reason, shall not be eligible to appear in these examinations.



- (i) Link for LOC / Forms will be provided on the CBSE website.
- (j) Strict adherence to the prescribed schedule is mandatory; no extension will be granted.
- (k) No subject change will be permitted.
- (l) Examinations will not be conducted in subjects already held by the Board.
- (m) No new candidate (regular or private) who did not appear in the Main Examinations 2026 is eligible.
- (n) List of subjects for which examinations will be conducted is annexed as **Annexure A**.
- (o) Schools are expected to carefully study this notification and guide their students accordingly.
- (p) Any other issue, as decided by the Board will be binding.
